Voltek Conditions of Sale

1. General

All quotations are given and all orders are accepted on the terms of the sellers CONDITIONS OF SALE and on any special conditions set out in its quotation and on no others. These conditions which supersede any earlier sets of conditions, shall override and exclude any other terms or conditions stipulated or incorporated or referred to by the buyer, whether in an order or in any other negotiations. The conditions of sale shall, at all times overrule conditions of purchase, and the signing by the seller of any of the buyers documentation does not imply a modification of these conditions is ineffective unless made by a written agreement between the parties.

2. Specifications

All descriptions and illustrations contained in the seller's brochures, price lists and advertisements or otherwise communicated to the buyer are intended merely to present a general idea of the goods described therein. Nothing contained in any of them shall form any part of any agreement of which the conditions of sale form a part. Notwithstanding that a sample of the goods may have been exhibited to and inspected by the buyer, it is hereby agreed that such a sample was so exhibited and inspected solely to enable the buyer to judge for himself the quality of the bulk, and not so as to constitute a sale by sample. The seller reserves the right to retail from its own premises goods manufactured by the company or factored products forming part of a product range.

3. Prices

All prices quoted or shown in catalogues, price lists or advertisements are net prices and exclude VAT & carriage, unless otherwise stated. Orders are accepted at prices shown in the seller's current price lists, but the seller reserves the right to amend these prices to those ruling at the date of despatch due to currency fluctuations or circumstances beyond the control of the seller, and to amend any accidental errors or omissions.

3. (continued)

Where prices are quoted in pounds sterling (with currency parity advised) the invoice value may be adjusted to cover the deviations from the specified rate, to the rate ruling at the date of invoice.

4. Payment

The payment will be due on demand unless otherwise agreed by the seller. Payment for credit account customers shall fall due 30 days after the date of invoice. The customer shall not be entitled to deduct from or set off against any sum that becomes due for whatever reason. The seller reserves the right to withhold deliveries until amounts due are paid in full. The seller may, at his discretion, charge interest to overdue accounts and this will be calculated at 3% above Barclays Bank PLC's base rate for the time being in force calculated on a daily basis.

5. Delivery

While every effort is made to supply the goods within a specified period, all delivery times are estimates only and the seller shall not be liable for failure to make the goods available within such periods. Under no circumstances shall the seller be liable to compensate the buyer, for damages or otherwise, non-delivery, late delivery of any goods or any loss, consequential or otherwise arising therefrom.

6. Carriage

The buyer shall pay the cost of carriage for all orders unless otherwise agreed by the seller. Unless the buyer requests otherwise goods will be despatched using the most economical service (3-4 days).

7. Loss or damage in transit

Goods lost or damaged in transit will be repaired or replaced at no charge provided that the buyer makes written notification of such damage or loss within 5 days of despatch date.

7. (continued)

If the buyer fails to give such notice the goods will be deemed to be accepted by the buyer.

8. Guarantee

All products sold by the company, with the exception of lamps, are covered by a 12-month parts & labour guarantee. The company shall not be responsible for any damage, loss or injury arising out of their use or handling.

9. Returned goods

No returns, including goods returned for service under warranty, will be accepted by the seller without prior arrangement. Returns will only be accepted in accordance with the sellers RMA process. Under ALL circumstances the buyer will pay the carriage costs of returning any goods.

10. Arbitration and Proper law

In the event of any dispute or difference arising out of the conditions of sale being settled by arbitration, then the provisions of the arbitration act 1950 shall be deemed to prevail. Any agreement incorporating the conditions of sale shall be governed by and be read and construed in accordance with English law.

11. Title

Title of the goods will pass to the buyer only when payment has been made in full and the buyer shall permit the servants or agents of the seller to enter onto the buyer's premises and to repossess the goods at any time prior thereto. The buyer may sell and deliver the goods to a third party in the ordinary course of a buyer's business on the condition that until such payment has been made to the seller, the buyer will hold all proceeds of such sales on trust for the seller.
